# 42) Public Session

The Chair requested any questions on items on the agenda:

## 45) Councillors / Clerk Matters

1. Vacancies

# Exelby, Leeming and Londonderry Parish Council

### <u>Re:</u> Proposed construction of 24no dwellings at land to the west of Sycamore Lane, Leeming (ref: ZB23/00923/OUT

Dear Sirs,

In response to the submission made by Saddington Taylor of 28 July 2023 the Parish Council wish the following statement to be considered:

Until 1989 the water utility was publicly owned, but on privatisation Yorkshire Water gained control of this utility that covers the village of Leeming.

In the years prior to privatisation this Parish Council had been in regular communication with the Water Board. Site visits were quite numerous, and the Water Board agreed that the situation required remedial action as it was unsatisfactory. However, with privatisation Yorkshire Water took over and informed the PC that there were no funds available.

All foul water from this village is discharged via an above ground, 10-inch pipe which crosses Bedale Beck, and which runs alongside the bridge that crosses the Beck.

Despite a valve being planted near Water Lane the sewage back flow in this region has continued and flows into gardens in that area. Sewage back flow also occurs in homes in Sycamore Lane and St John's Road.

Saddington Taylor indicates that Yorkshire Water's response (p2) would appear to be a verbal response made by an employee of the water company to one of the development's engineers. In their paper Saddington Taylor state that the Yorkshire Water employee's response was:

"...the majority of call outs our operational team attended in this area were to remove blockages caused by bricks, wet wipes, fat/oil/grease etc..."

If this has indeed been the case it will continue to be the case, but with a further 24 homes (a relatively large development in a small village) and their residents adding to the problem. Sewage flow back will continue to be a problem to current residents will also affect the residents of the new development should it be allowed to go ahead as all foul water will be discharged via the same pipes and any blockages will also affect all houses.

Sycamore Lane is to the east of the development site - not the west as stated by Saddington Taylor in the SuDs Management Plan, p7. According to the Flood Exceedance Plan provided the new water chamber is at the east of the site and not the west as stated.

The planned attenuation tank may well hold water to be discharged into the system, but the developers have failed to appreciate that the development on this greenfield site covers only the northern end of the field that is very often flooded and waterlogged. Since the drainage is planned to lie beneath the roadworks in the development the houses at the southern boundary (P01FFI through to P21/22FFL) will back onto this flooded area and there would be the strongest possibility of this water affecting the rear gardens of these houses and possibly seeping into the buildings themselves.

The objections relating to sewage and flooding by the Parish Council related to the impact and concerns on the wider community of the whole village rather than the narrow focus taken by the developers of only Sycamore Lane and St John's Road.

Under the heading of Surface Water Flood Risk, p2, Saddington Taylor has emphasised the fact that Sycamore Lane will be more prone to flooding in high-risk areas such as Sycamore Lane and mitigate their development from any impact in the future.

Further the responses from North Yorkshire Council, which is the Lead Local Flood Authority (dated 3/4/23) recommends that the submitted documents are limited and the LLFA recommends that the applicant supplies further information before any planning permission is granted by the LPS.

Requires further information relates to items:

- 1. Runoff destinations and peak flow
- 3. Design for Exceedance
- 5. Urban Creep
- 6. Maintenance and construction plan

To argue against the submissions by residents and the Parish Council based on absence of any such evidence is disingenuous.

#### <u>Highways</u>

If the developers have confined their focus to the narrow corridor of Sycamore Lane and St John's Road when discussion issues around drainage, they certainly haven't employed the same narrow focus under Highways, p5.

Saddington Taylor have stipulated (p5) that

"Traffic flows from a development of this size proposed would typically be considered modest or perhaps even negligible depending on the context."

They go further quoting the modelling used by National Highways

"Consequently, we do not foresee any significant impact from the proposed development on the SRN during the operational phase"

In the initial response by National Highways it is noted that:

"The applicant makes no reference to potential traffic to be generated by the proposed development and no supporting documentation has been submitted in this respect."

Given that the last two rentals by Broadacres in the village were for two elderly people who between them have three motor vehicles. Extrapolating from this we could assume that 24 houses will result in at least 36 vehicles being brought into play.

The SRN, or Strategic Road Network focuses on the impact on motorways and some A roads. The plan provided by National Highways shows they considered the impact of any generated traffic from the development would have on the following roads:

- Dere Street through Leeming-to-Leeming Bar
- Northallerton Road through Leeming Bar to the roundabout at the new bypass (A684)
- the new bypass (A684) to Coneygarth service station roundabout

We, the Parish Council, would concur with National Highways. The number of vehicles expected would have no significant impact on this section of the highway close to the village of Leeming.

It would seem to the Parish Council that Saddington Taylor are using provided outcomes for a road system removed from the development that have little bearing on the congestion that will occur in Sycamore Lane and St John's Road.

We have pointed out in our objection that there are no buses and no shops in the village, hence residents must travel by car for all their social, work and shopping needs.

We would urge the refusal of this development due to the negative impact it will have on the village and villagers of Leeming.
