#### 108) Highways

1. Heavy Goods Vehicles

Only one vehicle was seen using the village as a cut through after discussions with Highways.

# 2. Streetlamp - Hargill Lane, Leeming

The Clerk stated that Highways had sent an Officer to inspect the pole, but it is not an electric Lamp post and there are no funds available at this time to put a post down Hargill Lane.

Councillors requested that the clerk made representation to NYCC about the lack of light along the lane and request once funds are available that this area is considered with priority for lighting.

Action: Contact NYCC and Cllr JW requesting details as explained.

# 109) Playground

The Chair wanted to formally thank the Clerk for her work in obtaining the Lottery Grant to refurbish the Leeming Playground.

Councillors considered all three company quotations and albeit that they all had some variations within each quotation councillors did decide on a company. The consensus was that in terms of quality and best use of the funds the work would be awarded to Streetscape.

However, Councillors wanted the Clerk to renegotiate the revamping of the swings and the Wet pour underneath the swings. The following was requested:

- What does the £1K get the parish especially as the swings may not be repairable?
- Can the cost of the Wet pour be reduced considering the amount of funds already being allocated?
- Check with Streetscape layout of new equipment?
  Action: Clerk to speak to Streetscape about Swings

## 110) Grass Cutting

The Clerk confirmed the Grass Cutting Contract had been awarded to GCH Garden Maintenance as per their previous statement in January.
