 A resident Christine Mollard wanted to discuss and bring to the parish attention the new public bus service (53) for Londonderry & Leeming going into Bedale. The service going to Bedale means that residents can get to Bedale but cannot return unless they can do their shopping in 5 mins.

The request is that the Parish Council takes this up with North Yorkshire Council (Passenger Transport) to request a solution to this?

Answer: Councillors stated they were aware of the new timetable but was not aware of how time constrictive the timing of the journey to Bedale.
