This is to try and resolve the County Councillors constituents' boundaries before the next local elections due on the 6th May 2027. These are likely to involve Exelby Leeming and Londonderry Parish Council and Cllr Weighell stated he would not be standing so we will be getting a new County Councillor. These boundaries do not affect the parish boundaries, but parish boundaries are likely to be investigated later. At present there appears to be no change to our parish boundary being affected. 3. Solar Farm Personal view is I do not like these Solar Farms because they are not farms and you cannot grow anything on the grounds they are on. They are not efficient in the northern areas of this country when solar is poor except during the summer months. A Solar plant does not produce a lot of noise. However, a battery farms can be extremely dangerous. On a humanitarian ground how can a company justify enclosing a house in the middle of the Solar Farm which would destroy the value of that house and may well cause untold health issues to those having to live there. The Chair stated that the parish had lodged objections to the application on three issues and we await the outcome.
