101) External Sector Reports

- 1. Police Report
 - A verbal Police Report was given and noted.
- 2. District Council Report.

Cllr MB reported on the following:

- 1. The Green Bin Licences are now available to purchase art £40 and the collections have re-started.
- HDC adopted the Local Plan last week at a full Council meeting. Q: What will happen when we move to a unitary authority and will the new council adopt this? A: I don't really know but it will remain in place until the new authority produces their own plan. It took HDC from 2016 until now to get this plan in place so it will take a number of years before NYC collate their own plan to cover the whole of North Yorkshire.
- 3. HDC has successful refurbished Bedale Leisure Centre and has started the DE-Carbon Emission program. This includes upgrading of Leisure Centre with Solar panels and LED lighting
- 4. The new Crematorium, Maple Park is now open and will start to operate from the end of March.
- 5. Work has restarted on the cinema at Treadmill in Northallerton after a new contractor was appointed.

- 3. County Council Report

Cllr AW was unable to attend but sent in the following report:

Budget

At its quarterly meeting North Yorkshire County Council agreed a council tax increase of 3.99%, consisting of 1.99% general council tax and 2.0% of adult social care precept. This option results in a recurring shortfall of £18m and a need for reserves of £34.9m over the next three years. The County Council consulted the public about its budget, including the level of council tax. Under Government rules, the authority can raise council tax by up to 1.99% from April, plus up to a further 2.49% for the adult social care precept. The successful transition to the new unitary council arrangements will also be a significant feature of the forthcoming financial year. The County Council also has to grapple with increasing volatility in the months ahead due to rising costs associated with high inflation and uncertainty in relation to Government funding.

"Increasing council tax is never an easy option for us," said Cllr Les. "We have always striven to be moderate in our increases. We need to understand and balance the hardship families' face and the pressure a council tax rise might add with the need to fund essential services to support the most vulnerable in our communities and the services our communities and residents want to see delivered, none of which are without a cost."

Cllr Gareth Dadd, Deputy Leader and Executive Member for Finance, said: "These continue to be turbulent times. We are responding to increased pressures that the pandemic has placed on our communities and the county's economy. At the same time, long-term challenges grow, for example the massive pressures in social care. This means we face further tough choices as we budget for the future."

• Cycling returns to North Yorkshire with the Tour of Britain

Britain's leading cycle race, the Tour of Britain, will return to North Yorkshire on Wednesday 7 September. It was last in the area in 2009, when York welcomed the opening day's finish, and before that in 2008 when Dalby Forest hosted a stage finish. North Yorkshire's communities are well known for our wholehearted embrace of major cycling events, from the Tour de France Grand Départ to the Tour de Yorkshire and UCI Road World Championships, so large crowds are anticipated for this stage. It will begin in Redcar and Cleveland and promises to be a must-watch. We are still dealing with the pandemic, a range of staffing issues some of which are linked to Covid-19, service pressures in many areas.

102) Parish Council Reports

1. NYCC Jubilee Plant a tree

The Chair stated that the parish had decided at the last meeting to plant three trees one in each village. It was suggested that smaller trees would be more appropriate due to ongoing cost. The Chair suggested that perhaps British trees with recommendations and purchase from Braithwaite.

2. Digester Parking

The Chair produced some photos for the police regarding parking at the Emergency Exit gate near to the Digester and also on Roman Road where serious obstructions of parked cars near to school. The Police officer stated they would look into both issues to see if anything could be done and she would report back next month.

4. Community Notice Board Exelby

The Exelby community had raised £150 towards a new notice board and are awaiting for information about a grant. However, that wanted approval to place the Notice board either below the original board or at the side.

The Chair stated that unfortunately the parish budget for 2022/23 had already been set and if the village did need funds it would have to be in the 2023/24 budget plan. No funding requested at this time

Agreed in Principal to siting of the Noticeboard.

5. Lighting issues

The Clerk stated that HDC had confirmed that two new poles had been received and they are awaiting the electricity board to install them. This make take up to another 4 weeks.

6. Bench

The bench has been put at the side of the other bench that is unfortunately cemented into place. Cllr AB stated her partner may be able to assist and would get him to look into it. If the old bench can be saved a suggestion was to place it on Leeming Play area.

7. Moles

The Clerk stated that she had been contacted but she was out of the country at the time.
