4) **External Sector Reports**

1. Police Report

A report had been received and followed to councillors.

A verbal report was also given on the following number of incidents:

2. District Council Report.

Cllr CI reported on the following:

1. AGM of District Councillors due later this week.
2. 31st March 2023 will be the last day for the District Councils and the new authority North Yorkshire Council comes into effect on the 1st April 2023

3. HDC are opposed to the government scheme to house 1500 asylum seekers at the old RAF camp near Linton on Ouse and are seeking a judicial review of the government's decision.

3. County Council Report

Cllr JW introduced himself and reported he had only been in this role for a week with these new boundaries but had been a county councillor for a lot of years. He had previously served this ward in 1993 – 2005 but due to boundary changes he had served the Bedale / Aiskew Ward.

Again changes this year means he was again been elected for this ward.

He reported that Cllr Annabel Wilkinson would be a hard act to follow and she is now responsible for a very large constituency around Morton on Swale. He felt he would be unable to attend every meeting due to other commitments within the ward.

1. NYCC Jubilee Plant a tree

The clerk reported that she was due to meet with Braithwaites this week to discuss actual trees and siting of them.

After a short discussion a decision was made that the Leeming Village tree would be situated on the park where space allowed. The clerk was requested to get the trees and stakes with brass plates to commemorate the Queen's Platinum Jubilee. A suggestion was also made that a plaque was placed on the new bench in the village so that most residents would see that the parish was commemorating the Jubilee.
